Fifty Year Manufacturer's Warranty

This warranty remains in effect for a period of 50 years from the date of application, and is transferable and non-prorated.

COVERAGE

Zappone Roofing is warranted to be free from defects in original material and manufacture. The products are further warranted to be individually produced to the highest quality standards from Series 3000 Aluminum and coated with the finest PolyKynar... finish available, a finish developed for heavy duty exterior purposes and highly resistant to peeling, cracking, flaking, blistering and chipping. Zappone Manufacturing further warrants Zappone Roofing will not red-rust, burn or support combustion, split or crack from weather; and that Zappone Roofing has been tested to, and certifiably passed, independent laboratory wind and wind-driven rain tests and ICBO standards against fire and penetration. All warranted items are subject to the following terms and conditions.

EXCLUSIONS AND LIMITATIONS

This warranty does not cover damage of any kind resulting from faulty installation, accidents, structural settlement, distortion or shrinkage; or with the exception of the above provisions, tornado, hurricane, fire, lightning, ice storms, windstorms, hail, vandalism, earthquakes or other Acts Of God, harmful chemicals, fumes or vapors, misuse, abuse, normal weathering, impact of foreign objects, damage caused during shipping or storing or other causes beyond the control of Zappone Manufacturing.

Zappone Manufacturing maintains the right to redesign and discontinue or change any of its products. If any product covered by this warranty is no longer available, Zappone Manufacturing has the right to substitute a product of equal or greater value.

This guarantee is valid and in force only if Zappone shingles and accessories were used exclusively in the installation on the structure described herein. Zappone Manufacturing has the right to an authorized inspection of any claim against this warranty. Zappone Manufacturing's obligation is limited to replacement of covered defective material, upon claim and validation of claim, at no expense to the owner. Should Zappone Manufacturing be unable to replace the product covered, a refund will be provided. In no event shall Zappone Manufacturing's obligation exceed the manufacturer's original selling price of the materials in question. Any costs beyond the original selling price are the sole responsibility of the owner.

This warranty is issued under the Magnuson-Moss Federal Warranty Act. Zappone Manufacturing is not liable for any breach of any warranty or guarantee issued by any third party including dealers, contractors and installers. Implied warranties such as the Implied Warranty of Merchantability and Fitness are limited in time to duration of this express warranty. Zappone Manufacturing shall not be liable for incidental or consequential damages caused by any defects in product covered. Owner's exclusive remedy for defects in product covered is limited to the replacement or refund described herein.

REGISTRATION AND TRANSFER

This warranty is valid only after the completed warranty registration is received within 30 days of the installation. Zappone Manufacturing must be notified in writing of any transfer of registration within 10 days of transfer. Failure to do so will void the remainder of the warranty period.

CLAIMS PROCEDURE

Claims under this warranty must be submitted in writing to Zappone Manufacturing during the warranty period and within a reasonable amount of time after discovering the defect. The claim must include the original date of installation, and must be made by the owner.
